Immersive exposure to advanced innovation-led investment models

Day 3 involves a curated learning visit to the Greater Lausanne Region (Canton of Vaud), designed as an immersive journey into Switzerland's innovation and research ecosystems. Participants will travel from Geneva to engage directly with innovation-led investment environments, gaining firsthand insight into how advanced economies translate research excellence, technology, and innovation into globally competitive investment propositions.

Through structured institutional interactions and ecosystem briefings, the day will explore how innovation-driven regions support high-value investment attraction, R&D-intensive industries, and long-term economic competitiveness. The program also provides space for peer interaction, reflection, and informal networking in a cultural setting.

Indicative Learning Interactions

- **Global R&D & Innovation Leader**

Insights into how multinational companies structure global R&D operations, innovation pipelines, and location strategies for advanced manufacturing and technology investments.

- **Regional Innovation & Investment Authority**

Understanding how sub-national innovation and investment bodies support start-ups, scale-ups, and international firms, and act as gateways for foreign investors.

- **University–Industry Innovation Ecosystem**

Exploration of collaboration models linking universities, research institutions, and industry to build sectoral clusters and investable innovation platforms.

- **Cultural & Networking Experience**

Informal peer engagement and relationship-building in a cultural setting, reinforcing learning beyond formal sessions.
